The meeting began with a motion to approve the Minutes from the February General Membership meeting. A motion was made and seconded and the membership voted:

The beginning cash balance was \$26,650.14; the income \$336,748.26 total expenses \$165,117.27 with an ending cash balance of \$198,281.13. Michelle noted that as of February 28, 2009 the estimated balance of points to paid out (\$24,260.00). The defibrillator purchase approved in prior year (\$1,500.00), 50% of membership due to Orlando Membership (\$3,182.50). Deposit needed for banquet 2009 is (\$12,000.00). The beginning cash for Sand Dollar/Whitlow is (\$15,000.00); back out Sand Dollar/Whitlow balances (\$146,887.99). The National Fundraiser to be paid-out (\$2,136.70); the estimated cash is \$6,686.06.

Value Points – Leslie Cheney explain the value point process and gave the dead lines date May 31, 2009 and the dead line for the Elites is June this is for the points to be received. Our season is June 1, 2008 thru May 31, 2009.
